PUP-FOSTERING IS A COORDINATED EFFORT BETWEEN THE MEXICAN GRAY WOLF INTERAGENCY FIELD TEAM (IFT) AND THE MEXICAN WOLF SAVING ANIMALS FROM EXTINCTION PROGRAM AND IS A TECHNIQUE EMPLOYED TO ENHANCE THE GENETIC HEALTH OF THE WILD GENE POOL OF MEXICAN WOLVES. CAPTIVE-BORN PUPS ARE INTRODUCED INTO A SIMILAR-AGED WILD LITTER SO THE PUPS CAN GROW UP AS WILD WOLVES AND AID IN THE RECOVERY OF THEIR ENDANGERED SPECIES.

ACCORDING TO U.S. FISH AND WILDLIFE SERVICE (USFWS) MEXICAN GRAY WOLVES WITHIN THE WILD POPULATION ARE AS RELATED TO ONE ANOTHER AS FULL SIBLINGS. THIS PUP-FOSTER RECOVERY TECHNIQUE PROVIDES THE OPPORTUNITY TO AUGMENT THE POPULATION'S GENETICS WITH THE HOPE THE PUPS WILL EVENTUALLY SPREAD THEIR GENES TO THE GREATER POPULATION.

THE WCC HAS BEEN A CRITICAL PARTNER IN THE MEXICAN GRAY WOLF RECOVERY PROGRAM FOR NEARLY TWO DECADES. THE GOAL OF THE RECOVERY PLAN IS TO RESTORE MEXICAN GRAY WOLVES TO A PORTION OF THEIR ANCESTRAL RANGE IN THE SOUTHWEST UNITED STATES AND MEXICO. TO DATE, THREE ADULT MEXICAN GRAY WOLVES FROM THE CENTER HAVE BEEN RELEASED IN THE WILD AND 12 PUPS HAVE BEEN FOSTERED. WCC RESEARCH LAB ESTABLISHED IN 2021, THE INTEGRATIVE ECOLOGY AND COEXISTENCE LAB FOCUSES ON THE ECOLOGY AND CONSERVATION OF MAMMALIAN CARNIVORES.

A STRATEGIC GOAL FOR THE WCC RESEARCH LAB IS TO GROW INTO A HUB FOR RESEARCH, EDUCATION, AND OUTREACH ON THE MANAGEMENT AND CONSERVATION OF WILDLIFE WITH AN EMPHASIS ON WOLVES AND COYOTES. BECAUSE THESE AREAS HAVE APPLIED RELEVANCE, THEY ARE WELL-SUITED FOR INFLUENCING CONSERVATION POLICIES, ENGAGING THE PUBLIC IN ADVOCACY, AND ADVANCING WCC'S MISSION.

THE DIRECTIONS FOR THE RESEARCH AT WCC INVOLVES BUILDING OFF ONGOING PROJECTS FOCUSED ON UNDERSTANDING THE DISTRIBUTION, ECOLOGY, AND POPULATION DYNAMICS OF RED WOLVES, COYOTES, AND RED WOLF-COYOTE HYBRID POPULATIONS IN THE SOUTHEASTERN UNITED STATES AS WELL AS ESTABLISHING RESEARCH IN THE MID-ATLANTIC TO ASSIST IN ADDRESSING PRESSING CONSERVATION NEEDS IN THE REGION.

WCC RESEARCH LAB
IN 2021, WE ADDED A SENIOR RESEARCH SCIENTIST TO OUR STAFF AND IN 2022 WE CONTINUED TO BUILD OUT OUR SCIENTIFIC RESEARCH CAPABILITY VIA THE WCC RESEARCH LAB.

A STRATEGIC GOAL FOR THE WCC RESEARCH LAB IS TO GROW INTO A HUB FOR RESEARCH, EDUCATION, AND OUTREACH ON THE MANAGEMENT AND CONSERVATION OF WILDLIFE WITH AN EMPHASIS ON WOLVES AND COYOTES. BECAUSE THESE AREAS HAVE APPLIED RELEVANCE, THEY ARE WELL-SUITED FOR INFLUENCING CONSERVATION POLICIES, ENGAGING THE PUBLIC IN ADVOCACY, AND ADVANCING WCC'S MISSION.

THE DIRECTIONS FOR THE RESEARCH AT WCC INVOLVES BUILDING OFF ONGOING PROJECTS FOCUSED ON UNDERSTANDING THE DISTRIBUTION, ECOLOGY, AND POPULATION DYNAMICS OF RED WOLVES, COYOTES, AND RED WOLF-COYOTE HYBRID POPULATIONS IN THE SOUTHEASTERN UNITED STATES AS WELL AS ESTABLISHING RESEARCH IN THE MID-ATLANTIC TO ASSIST IN ADDRESSING PRESSING CONSERVATION NEEDS IN THE REGION.
